The committee has appointed a Rules Committee, all disputes will be referred to and be decided upon by this Committee. The members of the Rules Committee are as under: -



Dear Golfers,

We are pleased to announce "**The Bank of Baroda Corporate Golf League-2025-26**" to be played in the Rambagh Golf Club. The League shall begin on 4<sup>th</sup> November, 2025 and Launching / inauguration party of the Corporate League will be held on 1<sup>st</sup> November, 2025.

Details of the format and conditions of play are as under: -

**1. Teams:**

- All teams to be divided in four groups. Three group will have 9 teams and one group will have 10 teams.
- Each team shall consist of 8 Players of which any 6 Players will play 3 matches.
- Maximum handicap allowed for any player to participate in the tournament shall be "18".
- Players to be 16 years and above only.
- All males to Tee Off from Black, Blue, White Tees and Ladies from Red Tee.
- No professional shall be permitted to play.

**2. Tournament:**

The tournament in league consists of 3 matches, which are **Match Play**, **Alternate Shot** and **Two-ball Scramble**.

A match shall consist of 3 games as follows:

**GAME 1: FOURSOMES (Alternate Shot)**

In foursomes, each two-men team plays one ball per hole with the players taking turns until each hole is complete. Players alternate hitting tee shots, with one leading off on odd-numbered holes, and the other hitting first on even-numbered holes. The team with the low score on each hole wins that hole. If their scores are tied, the hole is halved.

**Handicap Allowance:** The allowance for the higher-handicapped side is 50 percent of the difference between the combined ***Course Handicap*** of each side.

**Example:** Side A-B with a combined Course Handicap of 15 competes against side C-D with a combined Course Handicap of 36. The higher handicapped side, C-D, receives 11 strokes ( $36 - 15 = 21 \times 50\% = 10.5$  rounded to 11). Strokes are taken as assigned on the players' respective stroke allocation table.

### **GAME 2. TWO BALL SCRAMBLE**

A scramble is played with two - person teams. Each player plays from the teeing area on each hole, one of the tee shots is selected and both the players play their second shots from that spot. One of the second shots is then selected, and both players play their third shots from that spot, and so on until the ball is holed. Ball may be placed within one club length not closer to the Pin.

**Handicap Allowance :** The allowance will be calculated by taking Player A (lower handicap player) 35% Player B 15%

**Example :** Player A '5' \* 35% = 1.75 round off = 2 Player B '18' 15% = 2.7 round off = 3 Team A+B = h'cap 5

### **GAME 3. TEAM MATCH PLAY**

Each match features two player from each team. Players with the lower scores on each hole wins that hole. If their scores are tied, the hole is halved.

**Handicap Allowance:** The match will be played with full handicap.

3. **Tournament Handicap:** Handicaps shall be displayed on the board for the Bank of Baroda Corporate Golf League - 2025-26 before the start of the League. Handicaps to be reviewed after every two matches in the Round Robin Stage, the committee shall review the Handicaps and a fresh list will be updated.

**The Committee shall have the discretionary authority to change handicap of a player at any stage during the League.**

4. **STAGES: -**

➤ **Round Robin Stage –**

- Each team has to play against other teams of their group
- 2 Points for a win
- For tied games points will be halved (1-1) to both the teams.
- 0 (Zero) Points for lost matches.

5. **Knock Out Stage:**

- Format for knockout matches to be **One Match play, one alternate shot and one Two-ball scramble.**
- Four top teams from each Group shall qualify for Elite Division and next four teams shall qualify for Plate Division. The remaining one / two teams from each group will be eliminated.
- Points awarded will be 2 for each win.
- In the knock out games in case of a tie at the end of 18 holes the teams shall continue playing in a sudden death playoff. The Playoff shall begin from Hole No.1 and handicaps / strokes shall be applied.
- Finals will be a two-day event played over **Saturday and Sunday**. First day will be two ball scramble, alternate shot and match play. Second day will be 6 singles matches for both Plate and Elite Division.

6. **Start:** All the matches to start from Tee No.1 & Tee No.10 in the first stage. All Men and boys shall play from the Black, Blue and White. Ladies shall Tee Off from the Red Tee. After the first stage all matches to be played from Tee No.1.
7. **Change of Player:** After 1 week of the beginning of the League, teams shall be permitted to change 1 player in the team. This will be done on making a request to the committee and a fee of Rs. 20,000/- (GST Extra) will be charged. The replaced player shall not take part in the tournament from any team.
8. **Toss and Fixture of Game:** Team Captains A & B shall announce the 3 pairs of their respective teams and then hold the toss. The Captain who wins the toss of coin (say, Team A) will choose the 1st pair and the format of play from the opposing team's announced pairs. The 2nd pair and format will be chosen by Team B, and the 3rd pair will be decided automatically. One match must be played by Friday. The date and time of each match shall be mutually decided by Two Captains latest by Tuesday. In case the teams fail to conduct the Toss within the stipulated time, the defaulting team shall be penalized with a walkover. The fixtures and schedule must be emailed to [admin@rambaghgolf.com](mailto:admin@rambaghgolf.com) or WhatsApp to 7300021452 to the club by Wednesday 12.00 Noon. Teams failing to inform as per the above instructions shall be awarded Zero (0) points.
9. **Mandatory Play:** In Case Captains of the two teams fail to reach an agreement on the time and date of their fixture, their matches shall be played **on the day** as decided by the Committee, the schedule of such matches shall be fixed by the Committee. In case of dispute of Morning (after 8.00 AM) / Afternoon (12.00 Noon onwards) Time then it will be decided by toss between the two teams.
10. **Etiquette:** The Team Captain shall be responsible to ensure that the players of his/her team follow rules and schedule etc. as laid down by the Committee from time to time. The players are expected to adhere golf etiquette in Section I. Use of foul language shall invite strict action. It is the duty of every player to repair **divots** and **pitch marks**, failing which appropriate action will be taken.
11. **Golf Carts:** Carts will be allowed to senior citizens (Age 65+) only. Any player below the age of 65 years using a Golf Cart will be disqualified. Even by mutual consent no Golf Cart will be allowed.
12. **Balls:** It is Mandatory to announce your ball before teeing off or if changed during the game. It is recommended to mark the ball for easy identification. Change of ball on the green for putting is not allowed.
13. **Caddy:** It is mandatory to take a caddy for all the Corporate League Matches. It is requested to pay 18-hole caddie money for every match including first stage and knockout. Fee on Saturday and Sunday for League matches will be Rs. 700/-.

**14. Time for Starting: -**

- Scheduled time of play is 8.00 am to 1.00 pm.
- Both players of a team failing to arrive 10 minutes after scheduled time will be awarded Zero (0) Points and match will be awarded to the team present at Tee Off.
- **Match-play and Scramble** – In match play and scramble formats one player from the team may start the match if the partner is not present at the scheduled Tee Time. The second player may join the match at the start of subsequent hole. However, a player cannot join during a hole already in progress. Handicap calculation for match play and scramble shall be done considering both partners together and finalized before the start of play.
- For alternate shot, both players must be present and ready to play at the scheduled start time. Failure to do so within 10 minutes of the Tee Time shall result in disqualification.
- If a team fails to report for it's match, the score card shall be signed by the players present and the Starter. The onus of providing proof of acceptance of the scheduled tee off time whether in hard copy or digitally will lie on the Players.

**15. Un-played Match:**

- If for some reason both teams are unable to finish their match against each other within the scheduled week, including the weekend schedule as per the committee, then the match shall be treated as a NO MATCH and both the teams shall get ZERO POINTS.
- If for any unforeseen circumstances/reason /unplayable conditions given in writing to the Committee, the match cannot be completed by Sunday Evening the Committee to decide the schedule for completion of match.

**16. Postponement:** The Committee reserves the right of rescheduling the fixtures.

**17. Concessions:**

A side may concede the following for the Opposing Side/player of Opposing side (and not each other in the side)

- \* A stroke
- \* A Hole
- \* A Match

Either of two players in a side making the concession will be determined as having done so on behalf of the player's side.

**18. Scorecard:**


- Signed Scorecard of all games must be filled with score of each hole and submitted in the club office. Scorecard declaring only final result will not be accepted.
- The Score card should be duly signed by all players.
- Any overcutting to be signed by the marker.

19. **Advice to Players:** Only the Captain may give advice to the teams during a match or designated person by the Captain from the reserved players not playing the tie. The same has to be announced to the competing team before tee off.
20. **PLEASE NOTE:** MATCH FIXING / CHEATING IN A GAME IS A SERIOUS OFFENCE. ANY TEAM FOUND BY THE ORGANIZING COMMITTEE IN ANY KIND OF FOUL PLAY, SHALL BE SUSPENDED / DISQUALIFIED FROM THE TOURNAMENT FORTHWITH.
21. Revised Rules of golf January-2024 will be applicable.
